Which Holiday Park Hot Tub or Spa?
A check list before making the correct business
investment

We supply and service nationwide including Chemical Supply and Water Treatment Training and have produced a brief 'Buyers Guide' designed to assist with your Holiday Park Hot Tub or Spa purchase.

Park Leisure Solutions Hot Tubs and Spas are manufactured in our established North American Factory, designed to satisfy and protect you with regards to all aspects of the HSG282 and in addition comply with Section 6 of the Health and Safety Act. To further reduce the stress sometimes associated with running a safe and simple Hot Tub or Spa, we offer Hot Tub management programmes in conjunction with Water Treatment products and RDHS - Health and Safety consultants, Water Treatment management courses are designed to help you and your staff understand the complexities of water treatment management, making the process simple and clear to understand.

Unlike a domestic Hot Tub or Spa a Holiday Park Hot Tub or Spa must be designed and built to meet HSG282 and the rigors of commercial use. HSG282 is primarily for those who manage or operate spa-pool systems and explains how to manage and control the risks from Legionella and other infectious agents. It also helps service providers, designers, manufacturers, suppliers and installers of spa-pool systems how to meet their legal responsibilities. This means the following specifications and operating features must be included in your Hot Tub or Spa to ensure the safety of your guests. If in doubt seek written confirmation from your supplier that the legal specification for Park use and operation has been met and the Hot Tub or Spa fully complies with HSG282. Domestic style Hot Tubs or Spas are not designed or built for commercial use.

Does the control panel reduce the risk for unnecessary staff call outs?

INSTALLATION ADVICE

Before you buy check any warranties for the Hot Tub or Spa. Park Leisure Solutions offer 2 years parts, 3 year lamination, and 5 year steel frame structure as standard. Check if the chosen supplier's product meets all the HSG282 criteria, as well as operating requirements and your budget. Then a site survey will normally be undertaken to assess the site and access and check all the necessary services are in place prior to installation. Park Leisure Solutions would normally project manage your installation which would be carried out by our qualified installers, saving you time and energy.

Further questions to consider:

- Will the supplier be available to service the product and advise on all aspects of establishing a service plan?
- Will the supplier offer full product training?
- Will the supplier offer parts pack and immediate emergency advice?
- Does the supplier offer a manufacturer backed warranty?
- Is the supplier willing to offer factory visits?

Remember, any manufacturer warranty could be invalid if your Hot Tub or Spa is not being used, or has not been installed, in line with the manufacturers terms of use.
